

OFFICIAL RULES OF THE GOLD TICKET GIVEAWAY AT ST. ANDREW'S HALL

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The Gold Ticket Giveaway at St. Andrew's Hall ("Promotion") is open only to natural persons who are legal residents of the United States of America (excluding residents of NY and FL), who have a valid social security or tax ID number, and who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. For all entries: Each participant is eligible to submit up to one (1) Promotion entry during the Promotion Period, regardless of method or combination of methods of entry or number of entries submitted. Each participant may also receive a maximum of two (2) additional entries via Friend Referral. Total entries into the Promotion not to exceed three (3) per participant. Prize: One (1) Grand Prize consisting of two (2) general admission tickets to each event of winner's choice at St. Andrew's Hall in Detroit, MI scheduled to take place in the 2017. Not valid for private events or rentals. Parking, travel, accommodations and all other expenses are not included and are solely the winner's responsibility. Tickets are subject to availability, venue capacity and age restrictions. Winner must submit ticket requests at least seven (7) days prior to event, with the exception of events taking place in December 2017, which must be submitted no later than December 5, 2017. Requests will be submitted through a dedicated reservation email address. Once tickets have been confirmed, winner must cancel request at least twenty-four (24) hours in advance of event or the face value of confirmed tickets will be included in the actual prize total for 1099 filing requirements. Tickets will be placed at Will Call under the winner's name. Winner must be present to pick up tickets; photo ID and Pass will be required. Tickets to a particular show are not guaranteed. Winner and guest(s) must abide by all venue policies. Live Nation reserves the right to revoke Pass in its sole discretion if it or venue personnel deem holder or holder's guest may be intoxicated, be a safety risk, have violated any venue policy or law, or may bring Live Nation into disrepute. Some blackout dates may apply. The Prize has no cash value and cannot be exchanged for cash or credit, except as required by law. In such event, Administrator reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
