

OFFICIAL RULES OF THE KEYS TO THE FILLMORE NEW ORLEANS SWEEPSTAKES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram or any other social network or platform. You understand that you are providing your information to Promotion Entities, and not to, Facebook, Twitter, Instagram or other social network or platform.

Eligibility: The Keys to The Fillmore New Orleans Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the continental United States of America who have a valid social security or tax ID number, and who are at least twenty-one (21) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable, federal, state, and local laws and regulations. Void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Administrator's decisions, which are final and binding in all matters related to the Promotion. Sponsor: The Sponsor of the Promotion is House Of Blues Entertainment, Inc. ("Sponsor").

Administrator: The Administrator of the Promotion is Live Nation Marketing, Inc. ("Administrator").

Timing: The Promotion period begins at 10:00 AM Central Time on June 21, 2018 and ends at 11:00 PM Central Time on September 15, 2018. Administrator's clock is the official time keeping device of the Promotion.

You may encourage your friends ("Friend Referral") to enter by sharing via your Facebook, Twitter, google+, or Pinterest account, or your Personal Referral link. You will receive one (1) additional entry for each successful sweepstakes entry via your Friend Referral, for a maximum of two (2) Friend Referral entries. For Friend Referral to be valid, entrant must use the Share icons or the Personal Referral link on the Confirmation Thank You page that will display upon successful entry.

For all entries: Each participant is eligible to submit up to one (1) Promotion entry per day during the Promotion Period, not to exceed eighty-eight (88) entries during the Promotion Period, regardless of method or combination of methods of entry or number of entries submitted. Each participant may also receive a maximum of two (2) additional entries via Friend Referral. Total entries into the Promotion not to exceed ninety (90) per participant. Multiple entrants are not permitted to share the same email address or other relevant account. Prize: One (1) Grand Prize consisting of two (2) general admission tickets to each of the public events of winner's choice at The Fillmore in New Orleans, LA scheduled to take place in the 2019 calendar year. *Tickets are subject to availability, age restrictions, venue capacity and artist restrictions. Tickets to a particular event are not guaranteed. Tickets are not available for rentals, private parties or non-Live Nation or House of Blues Entertainment produced events. Parking, transportation and accommodations are not included.* All other expenses not specifically mentioned herein are solely the winner's responsibility. Winner and guest(s) must abide by all venue policies. A ticket request must be submitted at least fifteen (15) days in advance of the event date, with the exception of events scheduled to take place in December, which must be requested no later than December 5, 2018. Guest(s) must be at least twenty-one (21) years of age. Winner and guest(s) may be required to show a valid photo identification (e.g., a valid state-issued driver's license) in accordance with venue policy, and winner must have valid photo identification to pick up tickets from will call. **Once a ticket request has been confirmed, the tickets will be considered delivered and fulfilled in accordance with Form 1099 filing requirements and will be taxable.** Any event tickets not requested will remain the property of Live Nation. Resale or transfer of tickets is prohibited. Approximate Retail Value of the grand prize is: Three Thousand Six Hundred Dollars and No Cents (\$3,600.00), depending upon

Selection and Verification of Potential Winner: Administrator will randomly select one (1) potential winner from all eligible entries on or around September 17, 2018. Administrator's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Administrator reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Promotion, or obtained winner status using fraudulent means.

All potential winners are subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Each potential winner will be notified by mail, email or phone. Each potential prize winner may be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release ("Affidavit") and an I.R.S. Form W-9 as applicable (except where prohibited), which must be received by Administrator within seventy-two (72) hours of the time notice or attempted notice is sent, in order to claim a prize (if applicable). If a winner is a minor, the Affidavit must also be executed by the winner's parents or legal guardians. If a potential winner of any prize cannot be contacted, fails to sign and return the Affidavit within the required time period (if applicable), declines the prize or prize is returned as undeliverable, such potential winner forfeits the prize. In the event that a potential winner is disqualified for any reason, Administrator will award the corresponding prize to an alternate winner by random drawing from among all remaining eligible entries. All alternate potential winners are subject to all requirements set forth in these Official Rules. Only three (3) alternate winners will be selected, after which the prize will remain unawarded.

Publicity: Except where prohibited, participation in the Promotion constitutes winner's consent to Promotion Entities' use of winner's name, social media identity, likeness, photograph, voice, opinions, hometown and state for promotional purposes in connection with this Promotion in any media, worldwide, without further payment or consideration.

Privacy: Information submitted by entrants will be collected by Administrator's systems based in the United States and such collection will be subject to applicable United States laws. Entrants may withdraw personal data upon request; however, entrant will be disqualified if personal data is withdrawn prior to the determination of the winner and fulfillment of the prize. Administrator reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Promotion Entities' reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Administrator in its sole discretion. In such event, Administrator reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Promotion Entities reserve the right to seek damages from any such person to the fullest extent permitted by law.
