

## OFFICIAL RULES OF THE OAKDALE BIG TICKET SWEEPSTAKES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram or any other social network or platform. You understand that you are providing your information to Promotion Entities, and not to, Facebook, Twitter, Instagram or other social network or platform.**

**Eligibility:** The Oakdale Big Ticket Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America currently residing within fifty (50) miles of the venue located at 95 S. Turnpike Road, Wallingford, CT 06452, who have a valid social security or tax ID number, and who are at least eighteen (18) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. In the event of a dispute as to the identity of an entrant, the authorized account holder of the account will be deemed to be the entrant. Administrator may request any potential winner to provide proof that such person is the winner. All potential winners are subject to verification before any prize will be awarded. Subject to all applicable, federal, state, and local laws and regulations. Void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**Sponsor:** The Sponsor of the Promotion is HOB Entertainment, LLC ("Sponsor").

**Administrator:** The Administrator of the Promotion is Live Nation Marketing, Inc. ("Administrator").

Sponsor and Administrator are collectively referred to herein as "Promotion Entities".

**Timing:** The Promotion period begins at 10:00 AM Eastern Time on January 1, 2018 and ends at 12:00 PM Eastern Time on January 31, 2018. Administrator's clock is the official time keeping device of the Promotion.

**How To Enter:** Via Internet, visit the Promotion registration page located at <https://goo.gl/BmJupv>, and complete the registration form. You may encourage your friends ("Friend Referral") to enter by sharing via your Facebook, Twitter, google+, or Pinterest account, or your Personal Referral link. You will receive one (1) additional entry for each successful sweepstakes entry via your Friend Referral, for a maximum of two (2) Friend Referral entries. For Friend Referral to be valid, entrant must use the Share icons or the Personal Referral link on the Confirmation Thank You page that will display upon successful entry.

**For all entries:** Each participant is eligible to submit up to one (1) Promotion entry during the Promotion Period, regardless of method or combination of methods of entry or number of entries submitted. Each participant may also receive a maximum of two (2) additional entries via Friend Referral. Total entries into the Promotion not to exceed three (3) per participant. Multiple entrants are not permitted to share the same email address or other relevant account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated technology or system to participate is prohibited and will result in disqualification. Any automated receipt (such as one confirming delivery of text message or e-mail) does not constitute proof of actual receipt by Administrator of an entry. Promotion Entities are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. All entries become the property of the Administrator and none will be acknowledged or returned.

**Prize:** One (1) Grand Prize consisting of two (2) general admission or reserved tickets to each of the public events of winner's choice at The Dome at Oakdale and The Oakdale Theatre in Wallingford, CT scheduled to take place in the 2018 calendar year. Ticket type and seat location for each requested event is at the sole discretion of venue. Tickets are subject to availability, age restrictions, venue capacity and artist restrictions. Tickets to a particular event are not guaranteed. One (1) show per artist / event if a show has more than one performance and/or date. Tickets are not available for rentals, private parties or non-Live Nation produced events. Parking, transportation and accommodations are not included. All other expenses not specifically mentioned herein are solely the winner's responsibility. Winner and guest(s) must abide by all venue policies. Live Nation reserves the right to revoke full or partial prize from any winner or winner's guest who it or venue personnel deem may, in its sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, or may bring Live Nation into disrepute. A ticket request must be submitted at least seven (7) days in advance of the event date, with the exception of events scheduled to take place in December, which must be requested no later than December 5, 2018. If winner is a minor in his/her state of residence, the guest must be winner's parent or legal guardian. Minors must be accompanied at all times during event(s) by minor's parent or legal guardian. Winner and guest(s) may be required to show a valid photo identification (e.g., a valid state-issued driver's license) in accordance with venue policy, and winner must have valid photo identification to pick up tickets from will call. **Once a ticket request has been confirmed, the tickets will be considered delivered and fulfilled in accordance with Form 1099 filing requirements and will be taxable.** Tickets will be placed at Will Call under the winner's name.

Winner must be present to pick up tickets; photo ID will be required. Tickets cannot be sold or bought. Prize will be revoked and void if sold or exchanged for compensation. Use of tickets for unauthorized advertising, marketing or other promotional purposes is strictly prohibited. Any event tickets not requested will remain the property of Live Nation. Resale or transfer of tickets is prohibited. Approximate Retail Value of the grand prize is: Fifty Dollars to Two Thousand Five Hundred Dollars (\$50 to \$4,500), depending upon ticket price for requested events and the number of event tickets requested by winner and confirmed by Administrator. The estimated number of public events is approximately forty (45). Any difference between stated approximate retail value and actual value of prize will not be awarded.

Winners agree to accept the prize "as is", and entrants hereby acknowledge that Promotion Entities have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to the prize, including express warranties (if any) provided exclusively by a prize supplier that are sent along with the prize. **Any valuation of the prize stated above is based on available information provided to Administrator and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes. Each winner must provide Administrator with a valid taxpayer identification number or social security number before any prize will be awarded. A Form 1099 will be issued to the winner for value of prize \$600 or more.**

**Selection and Verification of Potential Winner:** Administrator will randomly select one (1) potential winner from all eligible entries on or around February 1, 2018. Administrator's decisions as to the administration and operation of the Promotion and the selection of potential winners are final and binding in all matters related to the Promotion. Administrator reserves the right to disqualify any participant or winner and may refuse to award any prize to a person who is ineligible or has violated any rule, gained unfair advantage in participating in the Promotion, or obtained winner status using fraudulent means.

All potential winners are subject to verification by Administrator. Administrator will not accept screen shots or other evidence of winning in lieu of its validation process. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. **Each potential winner will be notified by mail, email or phone. Each potential prize winner may be required to sign and return an Affidavit of Eligibility, Liability and Publicity Release ("Affidavit") and an I.R.S. Form W-9 as applicable (except where prohibited), which must be received by Administrator within seventy-two (72) hours of the time notice or attempted notice is sent, in order to claim a prize (if applicable).** If a potential winner of any prize cannot be contacted, fails to sign and return the Affidavit within the required time period (if applicable), declines the prize or prize is returned as undeliverable, such potential winner forfeits the prize. In the event that a potential winner is disqualified for any reason, Administrator will award the corresponding prize to an alternate winner by random drawing from among all remaining eligible entries. All alternate potential winners are subject to all requirements set forth in these Official Rules. Only three (3) alternate winners will be selected, after which the prize will remain un-awarded.

**Publicity:** Except where prohibited, participation in the Promotion constitutes winner's consent to Promotion Entities' use of winner's name, social media identity, likeness, photograph, voice, opinions, hometown and state for promotional purposes in connection with this Promotion in any media, worldwide, without further payment or consideration.

**Privacy:** Information submitted by entrants will be collected by Administrator's systems based in the United States and such collection will be subject to applicable United States laws. Entrants may withdraw personal data upon request; however, entrant will be disqualified if personal data is withdrawn prior to the determination of the winner and fulfillment of the prize. In the event that production, technical, seeding, programming or any other reasons cause more than stated number of prizes as set forth in these Official Rules to be available and/or claimed, Administrator reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims. Administrator reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Promotion Entities' reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Administrator in its sole discretion. In such event, Administrator reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Promotion Entities reserve the right to seek damages from any such person to the fullest extent permitted by law. Promotion Entities' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
