

## OFFICIAL RULES OF THE WATERPARKS TOUR SWEEPSTAKES

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**Eligibility:** The Waterparks Tour Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America who have a valid social security or tax ID number, and who are at least thirteen (13) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Multiple entrants are not permitted to share the same email address or other relevant account. Use of any automated technology or system to participate is prohibited and will result in disqualification. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
